6. Items Ongoing

- Update on Broadband Wave 2: Shaun Dale (BT Openreach) has processed lists supplied by Council.
 Wave 2 plans are now progressing. There will be some properties in Minstead not included for which Mr Dale will give a price for fibre there may be grants available for some of these. Council is looking at crowd funding for Partnership with HCC and will consider how to launch a crowd funding project. Thanks were expressed to Cllr Taylor for all his work on this. Ongoing

7. Reports from County and/or District Councillor

<u>Cllr Edward Heron (HCC)</u> reported that Highways has a new contractor that has purchased new equipment. The contractor will work with Parish Lengthsmen (e.g. training) to extend range of tasks a Lengthsman can do.

Cllr Heron had been asked (Minutes 5 June 2017) how the *Reporting Rural Crime* joint Police/HCC venture would work. He reported that within the National Park it would involve NPA Rangers, not HCC.

He has yet to enquire about footpath signs at both ends of footway opposite Old Court House.

He has raised issue of traffic problems on Mill Lane/Blackwater Road. Council emphasised that signage to deter unsuitable vehicles would help. Alternatively make it one-way only.

Council raised the matter of a recent survey sent as online only. Councils need to have the survey document both to see all questions and to have evidence of their response to comply with transparency requirements. Cllr Heron will report this back to HCC.

Cllr Mrs Andrews (NFDC) reported:

Years of background work on local planning is coming to fruition and on 6 September planning
officers will brief Planning committee and Environment committee members asking for comment.
There have been a few unexpected changes particularly in areas around Ringwood where, with upto-date measuring, areas have been excluded due to possible flooding. This has caused delays.
However the plan will probably be published in December.
